SECOND AMENDMENT TO THE BY-LAWS OF P.O.A. OF THE SHORES, INC

NOW, THEREFORE, the By-Laws of the Association are hereby amended as follows:

(A) – Section 3.2 of Article 3 of the By-Laws is hereby deleted in its entirety and shall hereafter read as follows:

### Section 3.2. Number of Directors.

The affairs of the Association shall be managed by a Board of no less than three (3) and no more than seven (7) directors (herein, the "Board"), all of whom must be Members, or where such a Member is not an individual person, an officer, director, shareholder, partner or representative of the Owner of such Lot. The number of directors may be changed by Board Resolution, but in no event can be increase to more than seven (7) without amendment of these By-Laws. If the number of Directors is decreased by resolution, it shall not become effective until the Term of Office of the affected incumbent has expired (see section 3.5 below).

(B) - Section 3.5 of Article 3 of the By-Laws is hereby deleted in its entirety and shall Hereinafter read as follows:

## **Section 3.5 Election of Directors and Terms of Office.**

At every annual meeting of the Members of the Association commencing with the 2025 annual meeting of the Members of the Association, directors shall be elected to fill vacant or expiring positions. Vacant positions are those which have been created in accordance with section 3.2 or due to resignation, death, or disability in accordance with section 3.6. Expiring positions are those where the pre-existing term of office (e.g. 3 years) has ended. Each director elected to a newly created or expiring position shall serve a term of three (3) years except as required below.

Dependent on numbers of vacant positions, the elected terms of office may vary. Specifically, no more than two (2) positions shall be elected to a three (3) year term for each election. Should additional vacant positions present itself; the term will be for two (2) years and one (1) year respectively. In the case of position(s) created due to resignation, death, or disability in accordance with section 3.6. each director elected to this vacant position shall serve the remainder of the vacated term. Length of terms assigned will be based on number of votes received, i.e. more votes – longer term.

(C.) – Section 4.1 of Article 4 of the By-Laws is hereby deleted in its entirety and shall

Hereinafter read as follows:

## Section 4.1. Officers of the Board of Directors.

The officers of the Board of Directors shall be a President, Vice-President, Secretary, and Treasurer. All officers shall be elected from amongst the members of the board. The Board may appoint such other officers, including one (1) or more assistant secretaries and one (1) or more assistant treasurers, as it shall deem desirable. Such appointed officers to have such authority and perform such duties as the Board prescribes; however, such appointed officers are not entitled to cast votes. Any two (2) or more offices may be held by the same director, except the offices of President and Secretary which is expressly prohibited by Section 22.231 of the Texas Business Organizational Code.

(D) - Section 4.2 of Article 4 of the By-Laws is hereby deleted in its entirety and shall

Hereinafter read as follows:

### Section 4.2. Term of Office of Officers of The Board of Directors.

The Board shall elect officers at the first meeting of the Board following each election of director(s). Such officers shall serve until their successors are elected. Such meeting shall take place within 30 days after each election of director(s).
