This letter is to notify "The Shores" members and builders that work within community that there are new updates to the rules for construction activities.

The Board of Directors for the POA of the Shores, Inc. (BOD) recently updated many of the rules and associated fees and fines as they relate to building activities at the Shores. All of the updates were included in one document (the 18th Supplemental), which now are available on the Shores public website (<u>www.poaoftheshores.com</u>). In addition, the Architectural Control Committee (ACC) construction request forms will include updates in their "Contractor Job Site Expectations and Associated Fines" document.

The BOD highly recommends that you take time to read and thoroughly understand all of the new requirements and associated fines for noncompliance. These rules are not only for the primary builder, but extend to any subcontractors that may work on your projects. We as a Board serve for the best interest of the community, and preferably look first for compliance with the rules. We prefer not to fine the Shores members for builder noncompliance.

Please find below a table that outlines some of the changes you will find in the new documentation. Should you have any questions please contact Ron Hathcock, President, or the Architectural Control Committee.
